THE LIBRARY PROVIDES FREE ACCESS TO BOOKS, PERIODICALS, AUDIOVISUAL MATERIALS, PROGRAMS FOR CHILDREN AND ADULTS, INFORMATION, COMPUTERS, AND INTERNET ACCESS. THE LIBRARY ALSO HAS A MOBILE OUTREACH UNIT PROVIDING PROGRAMS AND RESOURCES TO AREA CHILD CARE FACILITIES.

FOR THE FISCAL YEAR 2009, THE LIBRARY WAS OPEN A TOTAL OF 13,246 HOURS (ALL LOCATIONS) AND SERVED A TOTAL OF 472,845 PERSONS, UP 3.5% FROM THE PRIOR YEAR. THE SYSTEM INCREASED ITS CATALOG TO 126,692 ADULT BOOKS, 58,768 JUVENILE BOOKS, AND 3,18 SERIAL VOLUMES, FOR A GRAND TOTAL OF 188,608 PRINT ITEMS. IN ADDITION, THE LIBRARY'S COLLECTION OF
