THE LIBRARY'S MOBILE PRESCHOOL UNIT VISITED 30 DAY-CARE CENTERS MONTHLY, PROVIDING LITERACY RESOURCES, STORY-TELLING, PROGRAMS, AND WORKSHOPS TO AREA CHILDREN AND THEIR CARE-GIVERS. THE LIBRARY PARTNERED WITH OVER 203 LOCAL AREA GROUPS AND AGENCIES, INCLUDING SCHOOLS, THE DEPARTMENT ON AGING, THE HEALTH DEPARTMENTS, SOUTHWESTERN COMMUNITY COLLEGE, WESTERN CAROLINA UNIVERSITY, THE SOUTHWESTERN COMMISSION, AND AARP, TO PROVIDE SERVICE AND INFORMATION TO THE PUBLIC.

AT A TIME WHEN SOME PEOPLE ARE SUGGESTING THAT LIBRARIES ARE NOT NEEDED, OUR STATISTICS SHOW THAT USAGE OF LIBRARY RESOURCES IS EVOLVING, AND THE LIBRARY REMAINS A VITAL PART OF THE COMMUNITY. THE LIBRARY IS THE HEART OF THE COMMUNITY, ENRICHING LIVES AND INSPIRING THE FUTURE.
